



- PURPOSE:** The Women's Hall of Fame annually honors women who have made significant contributions to Lebanon County through their profession and/or volunteerism while serving as role models.
- GUIDELINES FOR NOMINATION:** Women being considered are to:
1. Live and or work in Lebanon County or
 2. Have played an integral part in the implementation of project(s) that have benefited the Lebanon Valley or
 3. Have worked as Hidden Heroes touching lives in a positive way
 4. Nominees may be living or deceased
 5. Previous inductees are not eligible. Past Commission for Women members may be nominated after two years of being off the Commission.
- NOMINATION CATEGORIES:** Nominees should excel in one of the following categories*:
1. **Women Demonstrating Leadership:** Forging new paths in business or community while serving as a role model
 2. **Women Creating Community:** Contributing to the quality of life in the Lebanon Valley by supporting the social growth of the community
 3. **Women Promoting Agriculture:** Actively working to preserve and promote agriculture
 4. **Women Advocating Athletics:** Involved in amateur or professional athletics, coaching or administration
 5. **Women Working for Justice:** Striving for equality and peace
 6. **Women Promoting Healthy Lifestyles or Healthcare:** Educating, conducting research, promoting fitness, or providing health care
 7. **Women Contributing to the Arts:** Promoting the expression of the performing arts, visual arts, and literary arts
 8. **Women Innovating in Education:** Promoting innovation and inspiring personal growth
 9. **Women Serving the Military:** Advocating, supporting or serving
 10. **Women Fostering Advancements in Science/Technology:** Through research, development and/or education
 11. **Trailblazer:** Women who have boldly forged new paths for themselves, in their fields, or for enhancing the status of women and girls.

**During the selection process the selection committee may decide on a different category than submitted when reviewing all information received.*

Nominations are due October 31st for the next year. Nominees that are not selected may be resubmitted for consideration the following year. - b. *What has the nominee done to impact or make lives better in Lebanon County or beyond?*

- c. *How has the nominee worked to enhance the status of women and girls in Lebanon County?*

3. **Awards and Honors** (50 words or less)

- a. *Has the nominee won any significant awards or have they achieved any honors? Please describe.*

4. **Personal** (100 words or less)

- a. *How has the nominee inspired or mentored women and/or girls in the community?*

- b. *What qualities make the nominee an unsung hero?*

5. **Summary** (100 words or less)

- a. *In your own words, why should the nominee be inducted to the Women's Hall of Fame?*
